FACTORS THAT INFLUENCE ADOPTION OF POND FISH PRODUCTION TECHNOLOGIES BY FARMERS IN IMO STATE, NIGERIA

ABSTRACT

The study analyzed the influence of some selected factors on the adoption of pond fishery technologies by farmers in Imo State, Nigeria. Multi-stage random sampling technique was used in selecting the samples. The sample size was eighty (80) pond fish farmers. Data were collected through a structured questionnaire. Descriptive statistics such as mean scores, frequency and percentages were used to summarize data. The result showed that the grand mean for overall high influence of the tested factors was 4.2 which included source of water, availability of preferred fingerlings, complexity of the technology, interest rate on loan, availability of fish feed and other inputs, cost of construction and preparation of pond, general cost of fish production, availability of basic amenities, marketing of the fish, profitability, labour availability and general maintenance of pond fishery technologies. Inadequate land space and high cost of feeds and fingerlings were the determining factors of the size of fish farm, the number of ponds a fish farmer could own and the production level of farm. Feeds have been estimated to account for about 60 - 80% of total cost of production of fish depending on species and environment. Other serious factors that influenced the adoption of pond fishery technologies as perceived by the farmers include, complexity of the technology, availability of fish feed, cost of construction and preparation of pond and profitability of fish production. The study therefore recommended that more awareness should be created among the fish farmers about the fisheries technologies. Also, the cost of feeds and fingerlings should be subsidized by the Government to make them affordable by the farmers. Farm credit should be made available to the farmers to raise their capital base such that they can have the financial capacity to adopt and implement fishery technologies.

INTRODUCTION

The role of fish farming in achieving household and national food security and poverty alleviation in Nigeria cannot be over emphasized. Fish farming, an artificial method raising fish consumption, is an ancient practice that can still provide profitable means of livelihood for both rural and urban dwellers (Nwaneri., 2015). Otubusin (1987) defined fish farming as a practice of raising fish in an enclosed body of water such as ponds which can be concrete or earthen ponds that houses fish in such away that they cannot escape and at the same time allow for feeding, growth, breeding and harvesting in a well planned way. Fish farming was also defined by Ajieh (2010) as the act of rearing fish in enclosed water body under controlled conditions that aid their growth for human consumption. It is an important source of animal protein for a wider section of Nigeria society, creates employment opportunities and is an important source of income and foreign exchange. It is rich in vitamins and important dietary trace elements such as zinc, fluorine, selenium, phosphorus and amino acids and has high biological value (Campbell, Kenealy and Campbell, 2003). Fish in many ways is even more nutritious than most meat and warm-blooded animals. A well balanced diet from fish and shell fish products prevent an over production of hormones like eicosanoids from essential

fatty acids which can result in diseases as arteriosclerosis, thrombosis, arthritis and asthma. Fish is rich in polyunsaturated fatty acid which keeps blood cholesterol levels low and reduces the risk of coronary heart diseases. Another favourable aspect of fish and other aquatic animal compared with land animals is that they have a higher percentage of edible flesh hence there is little wastage. Access to accurate and adequate information on pond fishery technologies by farmers is essential for increased fish production. Such information must come from credible sources, at the right time, and for the farmers to adopt them correctly.

According to Nwaneri (2015), some of the constraints to increased fish production in include inadequate fingerlings Nigeria production, lack of earth-moving equipment, the high cost of fish feeds, low capital investment, and non-adoption of improved production and processing technologies by most fish farmers. The purpose of this study was to analyze the influence of some selected factors on the adoption of pond fishery technologies. The specific objectives were to: describe the socio-economic characteristics of fish farmers in the area; identify the sources of fisheries technology information to the farmers; analyze the farmers' perceived extent of influence of some selected factors

on their adoption of pond fishery technologies in the study area.

METHODOLGY

Study Area Description

Imo State is one of the 36 states in Nigeria located in the South Eastern part of the country. The land area of the state is estimated at 5,100.1 square km. The state lies within Latitude 4⁰ 45¹ and 7⁰ 15¹ North of the equator and Longitude 6^0 5^1 and 7^0 25¹ East of the Greenwich meridian. Apart from Imo River and Oguta Lake, the state is blessed with many inland waters such as the Igwu, Otamiri, Nworie, OramiriUkwa. Ogachi and OnukwuNjaba Rivers. The population of the state stood at 3,934,899 (NPC,2006). Generally, about 80 percent of the people engage in Agriculture. Extension services are fully funded by the state under Agricultural Development the Project (ADP). The state is divided into three agricultural zones, namely Owerri, Orlu and Okigwe zones. The zones are further broken down into blocks. A block is an agricultural area covering a specified number of villages and supervised by extension agents. Again, each block is further divided into circles or cells. Each block contains eight circles. A circle is an agricultural area containing a number of farm families. Thus, the Owerri zone has 18 blocks and 139 circles, Orlu zone has 10 blocks and 107 circles and Okigwe zone has 10 blocks and 80 circles.

In all, Imo state is made up of 38 blocks and 326 circles.

Sample Size and Data Analysis.

A multi-stage sampling procedure was adopted in the selection of blocks, circles and fish farmers. Total of eight blocks were randomly selected, four blocks from Owerri and two each from Orlu and Okigwe zones. Two circles were randomly selected from each block while five contact fish farmers were selected randomly from each circle giving a total of 80 respondents. A questionnaire was structured used soliciting information from the farmers. Objectives (i), (ii) and (iii) were realized with descriptive statistics such as means, percentages and frequency distribution. Mean scores from a five (5) point Likert type scale was used to determine the magnitude of response on the perceived extent of influence of some selected factors on adoption of pond fishery technologies (objective iv). The mean cut-off point was arrived at by finding the mean of the nominal likert scores. The mean adoption level was determined thus: $X_s = \frac{\sum X}{n}$

Xs of each was computed by multiplying the frequency of each response pattern with its appropriate nominal value and dividing the sum with the number of respondents to the items.

This is summarized with the equation below:

The cut-off mean was 3.0. Therefore farmers responses with mean scores of 3.0 and above were accepted and rejected if otherwise.

RESULTS AND DISCUSSION

Socio-Economic Characteristics of Pond Fish Farmers.

Table1 shows the percentage and mean distribution of respondents' socio-economic characteristics. The mean age of the farmers was 40 years. This shows that most of the pond fish farmers in the area were middleaged. Age is usually considered to be a primary latent characteristic in adoption decisions (Agbamu and Ohorhoro, 2007). The majority (73%) of the pond fish farmers were males while 28% were females. Most (91%) of the pond fish farmers were married. Thus, according to Nwaneri, Ibezim and Nwaneri; (2013), getting married is a highly cherished value among rural dwellers in Nigeria, not only because of the need for children and the

continuation of the family but also, because the women and children form a ready source of unpaid labour. The table also shows that 42.5% of them had post primary education. It is widely believed that education creates a favourable mental attitude for acceptance of new ideas and practices. It enables a farmer to seek for and utilize useful information from both print and electronic media, thereby accelerating the rate of adoption of technologies (Ozor and Madukwe, 2005; Agbamu and Ohorhoro, 2007). The mean household size of the farmers was seven. According to Iwueke (1987) and Nwaneri (2015), household size of seven is large. Large size of household might compel decisions to adopting good technologies to be able to provide adequate food for all members. The mean score for farming experience of the pond fish farmers was 14 years. Experience is important for effective day-to-day running of farm enterprise and could influence positively the adoption of innovations (Nwaneri, et al., 2013). The longer the years of farming experience, the more efficient a farmer is presumed to be. In other words, the experience gained all through the years in active farming will enable the farmer to make profitable decision and put him/her in a much better position to accept or reject innovation.

Sources of Information Used by the Pond Fish Farmers

Table 2 shows the mean distribution of respondents according to their sources of information. Majority (72.5%) of the farmers received information from Agricultural Extension agents. However

37.5% of them got information from Radio, 22.5% others received information through interaction with fellow farmers. This findings revealed that Television Journals and Agricultural shows were not common channels in the dissemination of information to the pond fish farmers.

Pond Fishery Technologies Extended to Fish Farmers

Table 3 shows distribution of the pond fish production technologies extended to aquaculturists in Imo State. The table revealed that Pond site selection, pond maintenance and fish harvesting methods were rated 70%, and pond

preparation/construction were rated 80%. Other pond fishery technologies extended to them include fish stocking and method of transportation of fingerlings (56%), fish feeding (53%) and fish preservation (60%) are the pond fishery technologies accepted by the farmers as being available in the area.

Farmers Perceived Extent of Influence of Some Selected Factors on Their Adoption of Pond Fish Production Technologies.

Table 4 shows the factors perceived by farmers to influence their adoption of pond fishery technologies in the study area. The tested factors are source of water. of availability preferred fingerlings, complexity of the technology, interest rate on loan, availability of fish feed and other inputs, cost of construction and preparation of pond, general cost of fish production, availability of basic amenities, marketing of the fish, profitability, labour availability and general maintenance of pond.

These 15 selected factors were responsible for adoption of pond fish production

technologies by fish farmers in the study area as they all scored high (X score ≥ 3.0). For instance, inadequate land space and high cost of feeds and fingerlings could determine the size of fish farm, the number of ponds a fish farmer could own and the production level of farm. Feeds have been estimated to account for about 60 - 80% total cost of production of fish depending on species and environment (Adeparusi, 2005). According to Ofor and Okpara (2005) and Nwaneri (2015), the realization of full potentials of aquaculture in Nigeria been limited by expensive fish feed. Similarly, Agbamu and Orhorhoro (2007) reported that inadequate fish production information and general cost of fish production could decrease the rate of technology adoption among fish farmers. Other serious factors that influence the adoption of pond fish production technology as perceived by the farmers include, complexity of the technology, availability of fish feed, cost of construction and preparation of pond and profitability of fish production.

CONCLUSION

The study analyzed the influence of some selected factors on the adoption of pond fish production technologies by farmers in Imo State, Nigeria. The result showed that the grand mean for overall high influence of the tested factors was 4.2. The factors include source of water, availability of preferred fingerlings, complexity of the technology, interest rate on loan, availability of fish feed and other inputs, cost of construction and preparation of pond, general cost of fish production, availability of basic amenities, marketing of the fish, profitability, labour availability and general maintenance of pond fish production technologies.
